## **NOTICE: CenterPoint Energy to perform North Loop – 1<sup>st</sup> St. N. job from April 13 to early summer 2020**

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

**Project Description:** CenterPoint Energy's project is anticipated to last from April 13 to late summer 2020. It will happen along the northern side of 1st Street N. between River Street and Hennepin Avenue. The project will be done in phases: **First Phase:** From BNSF Railroad to 8th Avenue N. This phase will start on April 13 and is expected to be completed by late May prior to the start of Minneapolis's 2020 Mill and Overlay Project. **Second Phase:** From Hennepin Avenue to 2nd Avenue N. This phase will start in early June and take approximately seven to eight weeks.

Crews from Michels Corporation, CenterPoint Energy's authorized contractor, will replace the natural gas main. Crews from Q3 Contracting, CenterPoint Energy's authorized contractor, will restore the areas affected by Michels Corporation's work outside the limits of the city's project.

**Traffic Impacts:** Work will occur in segments rather than all at once. For the majority of the project, the crews will work in the northern lanes, keeping two-way traffic in the southern lanes. Wherever active construction is occurring (typically two blocks at a time), parking will be prohibited on both sides of 1<sup>st</sup> Street N. For a limited time, the crews will close southbound 4<sup>th</sup> Avenue N. at 1<sup>st</sup> Street N., detouring traffic to West River Parkway, Plymouth Avenue, 2<sup>nd</sup> Street N., 3<sup>rd</sup> Avenue N. and 1<sup>st</sup> Street N.

These restrictions are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe. Local access will be maintained.
